This time last year, we launched the first edition of 'Business Law Today'. One year on, and we've had some brilliant feedback from readers, and are grateful for everyone who has engaged with our content and provided input to help shape our six editions so far.

Looking forward to this coming year, we will see the world's first artificial intelligence ('AI') legislation. The EU AI Act mandates compliance obligations for all 'actors' in the AI chain depending on their role and the level of risk in the AI system. Meanwhile, rather than introduce any generic AI legislation, the UK is taking a 'pro-innovation', principles-based approach, where sector regulators will develop

context-specific approaches. However, UK-based providers will still need to take account of the EU AI Act as its reach will extend beyond the EU and will apply to anyone supplying an AI system into the EU, and to AI systems providing outputs in the EU (which could be as simple as a website AI chatbot or an AI tool filtering job applicants for an EU-based employer). We will be talking more about this over the coming year, but in the meantime do contact us if you have any questions.

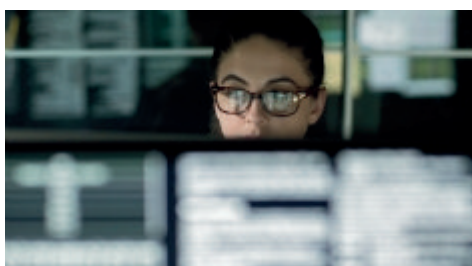
