Introduction

At Michelmores the third pillar of our Destination 2030 strategy, Significance of Impact, demonstrates our commitment to working with our charity partners in a collaborative way, with the aim of making a clear positive impact on the communities in which we operate.

Across our offices in Bristol, Cheltenham, Exeter and London, we organise a range of fundraising events to support our charity partners, from the Michelmores 5k Charity Run in Exeter (funds raised going towards an Exeter-based charity), sports matches, cake sales, quizzes, hikes, swims and so much more.

In 2024/2025:

Our Exeter office raised £2,571 and provided lots of kid's activity bags and Christmas hampers in addition to funds raised in the Michelmores 5k Charity Run. Our Bristol office raised £2,484, Cheltenham raised £1,817 and our London office raised £853 as well as providing advent calendars.

How we partner with Charities

We are now approaching the end of our current charity partnerships and we are now looking to collaborate with new charity partners. The next charity partnerships period will run from 1 May 2026 to 30 April 2029.

To apply, you must be a charity that supports the local community where a Michelmores office is based. Please note that our offices vary significantly in size so there will be variations in fundraising amounts and activities.

Our colleagues are keen to get involved with their local communities and to support local charities. One of the keys to a successful partnership with Michelmores is collaboration in order to build strong and enduring relationships. To this end, our Charity Partnership Group keeps in touch with our charities and holds regular meetings and reviews to ensure that every opportunity to work together is explored.

We are looking for charities that meet the majority of the key criteria below. Please review the guidance carefully before applying and include details of how you meet these criteria. You must:

- support our Destination 2030 strategy, which aims to help people navigate change to find a positive future
- deliver services or projects to support local communities within a location where a Michelmores office is based
- operate sustainably and actively manage your environmental impact
- strive to foster an environment of diversity and inclusivity

- be a UK registered charity
- engage our people through corporate volunteering (either virtually or in person)
- offer a variety of fundraising, volunteering and pro bono opportunities for individuals and teams
- if applying to the Exeter office, you must be able to offer some support at our annual Michelmores 5K Charity Run (such as marshals, volunteers, etc.).

Whether you are a new charity just starting up or an established charity looking for further support, we would be delighted to hear from you.
